Speaker <sup>4</sup>	Time <sup>4</sup>
Affirmative First Speaker (A) <sup>4</sup> - Presents the affirmative case <sup>4</sup>	3 mins <sup>4</sup>
Negative First Speaker (B) <sup>4</sup> - Presents the negative case and answers affirmative arguments <sup>4</sup>	3 mins <sup>4</sup>
Affirmative Second Speaker (C) <sup>4</sup> - Upholds the affirmative case and answers negative arguments <sup>4</sup>	3 mins <sup>4</sup>
Negative Second Speaker (D) <sup>4</sup> - Upholds the negative case and answers affirmative arguments <sup>4</sup>	3 mins <sup>4</sup>
Negative Cross Examination (BD → C) <sup>4</sup> - Holds the affirmative case against negative attacks <sup>4</sup>	2 mins <sup>4</sup>
Affirmative Cross Examination (AC → D) <sup>4</sup> - Holds the negative case against affirmative attacks <sup>4</sup>	2 mins <sup>4</sup>
Negative Rebuttal (B) <sup>4</sup> - Summarizes the debate and explains why the negative case should win <sup>4</sup>	2 mins <sup>4</sup>
Affirmative Rebuttal (A) <sup>4</sup> - Summarizes the debate and explains why the affirmative case should win <sup>4</sup>	2 mins <sup>4</sup>
